September 8, 2025 Coordinating Committee Teleconference Public Meeting: Held at 33 W. Third Street, Lyco. Conference Room 3rd Floor, Williamsport, PA 17701 and various locations via teleconference.

CALL TO ORDER (Regular WATS Technical Committee Public Meeting)

At 1:01PM Eric High called the meeting to order and also mentioned that this meeting will be recorded. Emily performed the roll call.

MINUTES

It was asked if there were any issues with the minutes from the previous meeting on February 10, 2025. No issues were found. Motion to approve was by Barb Schmouder 2nd by Scott Williams. Motion carried to approve the minutes.

PUBLIC COMMENT

There was no public comment.

ACTION ITEMS

Re-affirm e-ballot WATS MPO RVTA TIP Amendment:

Sal Vitko presented the reaffirmation for the e-ballot for the TIP amendment for the addition of federal funds to the WATS MPO RVTA TIP. It was approved via e-ballot prior to the meeting. Sal Vitko made the motion to re-affirm, Jenny Picciano 2nd. Motion unanimously approved.

2025 WATS MPO RVTA TIP Amendment:

Sal presented that this item adds the state and local match to the FTA funding to be added onto the TIP. Sal Vitko made a motion to approve, Barb Schmouder 2nd. Motion unanimously approved.

WATS bylaws updates:

Emily presented the changes to the WATS bylaws. Due to the restructuring of the Transportation Division, the Planning and Community Development Director will now choose the WATS Secretary. Jenny Picciano made a motion to approve the bylaws changes, Sal Vitko 2nd. Motion passed unanimously.

Transit Agreement:

Emily explained how a transit agreement is now required by Federal Highway Administration. It explains the tasks that WATS, PennDOT, and RVTA are already completing. Once passed, the agreement will go before the Lycoming County Commissioner's for approval before going back to PennDOT. Justin stated that the creation of the document was from the STIP finding from the last TIP update. Barb Schmouder made a motion to approve the Transit Agreement, Scott Williams 2nd. Motion passed unanimously.

DISCUSSION ITEMS

2027 TIP Update:

Emily explained that the MPO is working on the TIP, working with Justin and District 3-0 to update amounts and projects for the 2027-2030 TIP. Chris stated that District 3-0 is hoping to have a list of projects by the end of the month circulated by email. District 3-0's goal is to have the TIP uploaded to MPMS by Thanksgiving. Everyone is working diligently to meet that deadline. Sal stated that RVTA is finalizing their list of projects for the new TIP. They are waiting on PM's from BPT. Justin stated that we have had 2 TIP meetings so far and both have gone well. Emily sent Justin a draft to look over and he will get it back to her when he is finished reviewing it.

Modal Updates:

RVTA: Sal was present to provide an update. He explained the TIP amendments that were approved, it captured 2020 5307 funding from FTA. In the near future they will be submitted to receive 2023, 2024, 2025 on the 2027 TIP update. Regarding the Transit Development Plan, BPT gave the go ahead to STB Inc. to submit their final scope of work. They are hoping to have a kick off around the beginning of October. The study will be approximately 1 year. Capital

projects that are currently happening are the installation of a bus wash with water reclamation,

purchasing 3 35' natural gas Gillig buses, and structural and access control repairs to the Church

Street Parking Garage. Their ridership is nearing pre-pandemic numbers. To-date, they have had

796,000 riders which is an increase of 8,200 from last year. Regarding the Little League World

Series buses, they provided service to an additional 23,000 people with 6,900 miles traveled.

Williamsport Regional Airport: Eric was not present.

SEDA COG JRA: Steve was not present.

STEP Inc: Daniel was not present.

Management Action Report:

Chris reported that \$656,000 in TIP redistribution funds from another program with granted to

the MPO. The money was put toward the Montgomery Borough bridge rehab. The MPO also

received PROTECT funds from Central office to distribute to build resilient transportation

systems and in our area, it typically goes towards flooding. These funds will be going towards

the bank stabilization project on Warrensville Road. The PROTECT funds will fund this project

which allows the money to be added to another project. A new project was added regarding the

Queneshukney bridge. Finally, there was cost estimate reduction on SR 284 which means it will

not have to be carried over. Eric stated that District 3-0 aggressively pursues the PROTECT

funds as they are used for erosion and flood damage from flooding events which is a large issue

in Lycoming County.

OTHER BUSINESS/PUBLIC COMMENT

There was no public comment.

Dear Planning Partners:

Pursuant to the Code of Federal Regulations (23 CFR § 490) regarding National Performance Management Measures for the Highway Safety Improvement Program (HSIP), Pennsylvania has established the 2026 targets for the following Safety Performance Measures:

- 1) Number of fatalities
- 2) Rate of fatalities per 100 million Vehicle Miles Travelled (VMT)
- 3) Number of serious injuries
- 4) Rate of serious injuries per 100 million VMT
- 5) Number of non-motorized fatalities and serious injuries

The Pennsylvania Department of Transportation (PennDOT) is required to establish these targets by August 31 each year. The 2026 targets found in Table 1 of the enclosure are based on a data driven trend analysis of the statewide fatality and suspected serious injury numbers (2 percent annual fatality reduction and maintaining level suspected serious injuries).

Metropolitan Planning Organization (MPOs) are required to establish targets within 180 days of PennDOT establishing its targets (by February 27, 2026) either by agreeing to plan and program projects in support of the PennDOT targets, or by establishing their own quantifiable targets. For consistency, PennDOT is requesting Rural Planning Organizations (RPOs) follow the same procedure. Table 2 of the enclosure reflects values for your MPO/RPO based on the same methodology that was used at the state level. MPOs/RPOs wishing to establish their own quantifiable targets are requested to coordinate with PennDOT as early as possible, but no later than December 31, 2025.

A state is determined to have met or made significant progress toward meeting established targets if the outcome in 4 of 5 performance measures is better than the baseline number. For Pennsylvania's 2024 targets, the Federal Highway Administration (FHWA) will report this determination by March 31, 2026.

Based on preliminary data, we do not expect Pennsylvania to meet our 2024 targets and anticipate will be subject to the provisions of 23 United States Code § 148 (i). This will require the Department to submit an implementation plan that identifies gaps, develops strategies, action steps and best practices, and includes a financial and performance review of all HSIP funded projects. This plan will be due June 30, 2026. In addition, we will be required to obligate in Federal Fiscal Year (FFY) 2027 an amount equal to the FFY 2023 HSIP apportionment (\$128,666,054).





HOW TO READ THIS REPORT

The enclosed report, "MPO TIP WITH STATE MATCH, ENCUMBRANCES AND EXPENDITURES" accompanies the individual MPO quarterly report. It identifies specific projects and provides details regarding obligations and encumbrances/expenditures on those projects. This report also shows the state match associated with projects that had obligations during the period.

The following is an explanation of the items in this report:

- The first column "MPMS" is the project identification number in the multi-modal project management system (MPMS).
- "Short Title" is the name of the project as it can be found in MPMS.
- "Phase" is the list of phases associated with a particular project that is on the Transportation Improvement Program (TIP).
- "District" is the engineering district where the project is taking place.
- "County" is the county where the project is taking place.
- "SR" and "Section" define the State route and section number assigned to the project.
- The federal funds obligated during the period can be found under "Obligations." These represent federal authorizations to proceed with specific project phases.
- The corresponding state match, if any, can be found in the column entitled "State Match."
- "Encumbrances/Expenditures" are 100% state funds associated with the project, and are also reported by phase.
- The next four columns are the dollars programmed on the TIP for the project sorted by TIP year, the proceeding four columns are totaled in the last column entitled "Program Total."
- Entries that contain a "0" in the "Program Total" column are individual project phases that were not on the TIP as of September 30, 2020 and were since then added to this report.
