**Notice to Absentee and Mail-in Voters:** A voter who receives an absentee or mail-in ballot and appears at a polling place to vote in person on Election Day may only vote by provisional ballot, unless the voter surrenders the official ballot and official ballot return envelope to the Judge of Elections at the polling place to be spoiled.
