**Instructions:** To vote your ballot, completely fill the oval beside a choice using black or blue pen. To cast a write-in vote, fill the oval beside *Write-In* and write a name in the space provided. The use of a sticker or label to mark a ballot is prohibited by state law. A vote cast by means of a sticker or label shall be void and shall not be counted. Do not select more choices than permitted in each contest. If you make a mistake while voting your ballot, do not attempt to erase or cross out the mistake; instead, request a new ballot.

**Notice to Absentee Voters and Mail-in Voters:** A voter who receives an absentee ballot or mail-in ballot and appears at a polling place to vote in person on Election Day may only vote by provisional ballot, unless the voter surrenders the official ballot and official ballot return envelope to the Judge of Elections at the polling place to be spoiled.
